1. Living Labs to Deliver Experimentation Services under the EVOLVE2CARE Project

1.1. Background and Objective

European Network of Living Labs (ENoLL) is launching a targeted subcontracting call under the Horizon Europe-funded EVOLVE2CARE project (Grant Agreement No. 101158152), aimed at engaging Living Labs to deliver experimentation services to selected HealthTech innovators.

1.2. Scope of Work

Selected Living Labs will:

- Deliver experimentation, co-creation, testing, and validation services
- Collaborate with selected innovators under a mini-consortium
- Implement activities as described in the jointly submitted application under the EVOLVE2CARE Open Call
- Services must align with one or more of the categories listed in the Open Call Guidelines (e.g., usability testing, co-creation, clinical trials, prototyping, foresight).

1.3. Eligibility Criteria

To be eligible for this subcontracting call, applicants must:

- Be legally established in an **EU Member State or Horizon Europe Associated Country**
- Have successfully **participated in the EVOLVE2CARE Open Call matchmaking and mini-consortium formation process**
- Be included in a **shortlisted proposal recommended for funding** under the EVOLVE2CARE Open Call

1.4. Award Criteria

Subcontracting will be awarded to proposals that meet the eligibility conditions and are ranked for funding under the EVOLVE2CARE Open Call. Awards will follow the order of the final ranking list from Phase 1 of the Open Call and will be made **subject to budget availability**.

1.5. Budget and Duration

- Maximum subcontract value: **€5,000** per Living Lab
- Services must be completed within the timeline defined in the Open Call (maximum of 6 months)
- Payment in full upon submission and approval of final report and achievement of KPIs

1.6. Contracting Process

Once awarded, the successful Living Labs will be contacted by ENoLL to sign a non-negotiable **Services Agreement**. This contract will reference Horizon Europe subcontracting obligations (esp. Article 6.2.D.3), outline KPIs, reporting obligations, and payment terms, and include clauses on conflict of interest, data protection (GDPR), EU visibility, and audits.

The signed **Declaration of Collaboration** and the agreed **Service Description** will be attached to the Services Agreement.
